Hello,

I wanted to try to summarize what we've learned so far about the Church's options for staying/leaving the United Methodist Denomination. First, let me give you the conference website Local Churches — NWTX Conference (www.nwxtconf.org/local-churches). If you are reading this electronically, you can click on the link and be taken to the Conference website that gives all the information about this issue. If you are reading this on paper, you will need to enter the website inside the parenthesis in your search bar on your computer to be able to visit the Conference website. Either way, I encourage you to go to the Conference website and sort through all the links and read all the information you can, especially the Transitional Book of

Discipline for the Global Methodist Church.

One of the most important things you need to understand is that we, you, as the Church and I, as the pastor WILL have to decide to either stay United Methodist (UMC), leave the UMC for a different Methodist denomination, like the Global Methodist Church, or go independent. The Judicial Council, the Supreme Court of the United Methodist Church, has ruled that an Annual Conference cannot legally leave the United Methodist Church, so FUMC Vernon and all other churches with the United Methodist Denomination must decide for themselves what path they want to follow. What is below is taken directly from the Conference website and outlines what we need to do. The Conference suggestion is to begin this process directly following Annual Conference but as your pastor, I am encouraging us to begin this process now. I realize that everything that is below is as clear as mud, so if you have questions, please do not hesitate to reach out to me and I will do my best to answer your questions.

Since the Judicial Council ruled that it is illegal for the Annual Conference to leave the UMC, churches will need to enter a discernment process about staying in the UMC or exiting under paragraph 2553 in the 2019 Addendum to the 2016 Book of Discipline:

- 1. Every local church's leadership team will be challenged to spend two weeks praying and fasting to seek God's direction for their future.
- After the season of prayer, the Church Council (or equivalent leadership group) will call a church-wide meeting
 or series of meetings to discuss if their church should remain in the UMC or start the process to leave under
 paragraph 2553.
 - a. A conference representative and resources will be made available for these meetings.
 - b. These meetings are only for information and conversation. No official vote will be taken.
 - c. Information will be distributed on the disaffiliation process and the cost of leaving under paragraph 2553.
 - d. If the church wishes to disaffiliate by December 31, 2022, they will be required to pay 100% of their Shared Ministries for 2022 by November 15, 2022. The remainder of their disaffiliation costs (unfunded pension withdrawal liabilities and 2023 Shared Ministries) will be covered by the conference's reserve funds.
 - e. Point d listed above is dependent on the June 2022 annual conference approving the Conference Council on Finance & Administration's document NWTX Transition Process Financial Framework that supports these recommendations.
- 3. Each local church will be challenged to spend an additional two weeks after the church-wide meeting praying and fasting to seek God's direction for their future.

- 4. After the two weeks of prayer and fasting, the Church Council will ask the District Superintendent to call a Church Conference to take a vote.
- 5. The District Superintendent or an assigned elder will lead the called church conference.
 - a. Only professing members of the local church who are present may vote.
 - b. The vote will be between two options (2/3 majority required):
 - i. Remain in the UMC (this could be because the church needs more time to make their final decision or because this is their long-term desire).
 - ii. Disaffiliate and leave the UMC.
- 6. If the vote to disaffiliate reaches the 2/3 majority, the church will proceed to the following steps.
 - a. Local church Trustees sign a binding Disaffiliation Agreement provided by the annual conference.
 - b. Local church must submit all funds they owe for disaffiliation to the conference treasurer by November 15, 2022.
- 7. Bishop Nunn will lead a special called session of annual conference on 12/3/22 to give annual conference ap proval to all churches who have completed all steps to disaffiliate. The effective date will be 12:00 a.m. 1/1/23.
- 8. Local churches who have completed this process can choose to unite with other NWTX churches who are exiting to join the GMC, go independent, or join another denomination. These exiting churches will retain all assets, liabilities, and property.

Churches may decide to postpone their decision about their future until a later date.

- 1. Local churches may need more time to work through their decisions about their future. They would need to ensure they follow the process above to remain in the UMC while making this decision.
- 2. Two more seasons for disaffiliation under paragraph 2553 will be made available to churches in 2023:
 - a. January June 2023: those churches who need longer to work through their decision will have another opportunity in early 2023 to move toward a July 1, 2023 separation date (final vote taken at annu al conference June 2023).
 - b. June December 2023: those churches who may want to delay even longer can take advantage of the final window available under paragraph 2553 for a December 31, 2023 separation (final vote taken at a yet to be called session of annual conference December 2023).
- 3. Churches could later choose an alternate path such as transferring to another denomination under paragraph 2548.2 in the 2019 Book of Discipline or another path provided by General Conference in 2024 or at a lat er date.

Disclaimer: Any of these paths outlined in this document could be changed by the actions of a future General Conference as it relates to the Book of Discipline or the actions of the annual conference or its leadership as it relates to annual conference policy.
